## **Section 4 - First Aid Measures**

#### **General Information:**

## **Section 5 - Fire Fighting Measures**

## **Section 6 - Accidental Release Measures**

Accidental release: Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. No special protective clothing is normally necessary because of this product. However it is good practice to wear overalls, goggles and gloves when handling chemicals. No special recommendations for clothing materials. Eye/face protective equipment should comprise as a minimum, protective glasses and, preferably, goggles.
